



Nisqually Beautification Program Application

PURPOSE: The intent of the Nisqually Beautification Program is to provide Nisqually Tribal Members that own homes on the Nisqually Reservation, Pierce & Thurston counties the opportunity to improve their homes safety, quality and to enable improvement of the existing physical conditions. This program is not intended to replace other low-to -moderate income Housing rehabilitation programs, when and if the Homeowner is eligible, or weatherization programs. The Beautification program deals primarily with addressing health and/or safety repairs especially regarding internal electrical, plumbing systems and when safety/security is an issue on the perimeter of an elder applicants' home. This program also authorizes overall exterior renovations to improve the condition and appearance of all homes owned on the Nisqually Reservation.

Beautification Policy 2025 & Guidelines

The Beautification program was designed to perform needed repairs and improvements to existing residential houses **owned** by Nisqually Tribal members residing in the reservation boundaries or within Thurston and Pierce counties.

Program Qualifications

- Must be a Nisqually Tribal Member.
- Must live within Thurston or Pierce counties.
- **Applicants must not contact or go under contract with a contractor prior to Building Department approval.**
- Access to areas of the house being worked on need to be open to workers during daytime hours Monday to Friday.
- Pets must be controlled so that workers are not bothered or endangered by them.
- Workers must be treated respectfully while working on property.
- Change orders or additional work must be approved by the building department.

This program can help with the following:

- Life & Safety items
- Roofing Repairs
- Siding Repairs
- Exterior trim
- Exterior paint
- Replacement of broken windows/doors
- Porch repairs/rebuilds
- Junk removal
- Landscaping cut down
- Fence building/repair
- Plumbing and bathroom repairs (limited basis per the severity of needs)

This program cannot help with:

- Pest Services, Roden Removal, Bees/Wasps nest removal
- Tree Trimming/Removal
- Septic Servicing & Repair
- Interior Remodeling
- Exterior additions or remodeling

The work is scheduled on a first-come, first-served basis using a detailed and numbered list of applicants which is kept at the building department. Some exceptions for safety or emergency repairs may be considered for approval of the Building Department director Wayne Lloyd. The budget is **finite** and changes from year to year which will affect the number of Tribal Members that can be served each year.
